Fee Concession for Non-DAE students :-

The Non-DAE category students who were granted admission in AEC Schools till the academic year 2017-18 and whose parents' (both father and mother) combined Annual income is less than Rs. 2.5 lakhs, they are presently extended the fee concession of 50% in the tuition fee alone. This concession will be extended to the student concerned on production of the income certificate of parents issued by the competent revenue authorities. No fee concession for Non-DAE students admitted from the academic year 2018-19.

Dates of fees collection:- [without fine]

11.04.2025 to 30.04.2025.

Dates of fees collection:- [with fine of Rs. 50/-]

01.05.2025 to 15.05.2025.

NOTE : A fine of Rs.10/- per day for PUVVN and Rs.10/- per day for tuition fee will be levied up to the last working day of the month and after which the name shall be struck off the role due to nonpayment of dues and re-admission will be done on payment of Rs.100/- along with late payment fee.

- 3) Read the Disclaimer Clause and click on "check box" and "proceed" button for making payment.**
- 4) Select State - "Karnataka"**
- 5) Select Type - Education Institutions (click "Go" button)**
- 6) Name of the Institution - "Atomic Energy Central School, Mysuru"
- Submit**
- (For AEES Fee)**
- 7) Select Category**
- 8) Payment Category - Select "AEES Fees" (Enter the details, applicable fees & columns)**
- 9) Submit - Click on the "Submit" button, verify all the details on the next page and click on "Confirm"**

(For PUVVN Fee)

- 10) For PUVVN Fee – Return to SB Collect Home Page :-**
- 11) Name of the Institution – “Atomic Energy Central School, Mysuru”
– Submit**
- 12) Select Category**
- 13) Payment Category – Select “PUVVN Fees” (Enter the details,
applicable fees & column)**
- 14) Submit – Click on the “Submit” button, verify all the details on the
next page and click on “Confirm”**
- 15) After the final fee entries for both the fees, the name & date of
birth of parent may be given for obtaining the Receipt & go for
print option.**

- 04) Go to SB Collect (left top corner tab)**
- 05) Select Reprint Remittance form (to download e-challan for payment)**

Dates of fee collection through SBI COLLECT- 11/04/2025 to 30/04/2025. (No cash deposits please)

1. Read the Fee Circular Thoroughly: Before proceeding with the payment, go through the fee circular carefully for all necessary details.
2. **No** Cash Deposits: Cash payments will **not** be accepted under any circumstances.
3. Payment Mode: All fees must be paid only through **SBI Collect** only. 🖱️
4. Correct Entry of Fee Details: Ensure that all applicable fees—such as PUVVN Fee, Tuition Fee, etc.—are entered correctly as per the selected term.
5. **Avoid** Payment Errors: Please do not pay less or excess amounts.
6. **No** Cross Payments: Do not make cross-over payments (e.g., paying PUVVN Fee into the AEES Account and vice versa).
7. Receipt of Payment: After successful payment via SBI Collect, take a printout of the acknowledgements/ receipts.
8. Submission of Receipt: Submit one hard copy of each fee receipt(PUVVN & AEES) to the concerned class teacher.
9. Timely Payment: **Avoid late payment** of fees as it may result in unnecessary penalties.
